The registration fee is due at time of enrollment. Tuition is due the first day of class or upon continuation of a contract. A late fee of \$15 per week will be charged for any tuition more than 3 days late. Students with open balances are not allowed to re-enroll until all balances have been paid. All contracts for fewer than 8 weeks, private tutoring, and the Achievement Program courses must be paid in full before the first day of class.

Tuition is due the first day of class. If tuition is more than 3 days late, a late fee of \$15.00 per week will be charged.

Refund Policy

1. The \$50.00 registration fee is non-refundable.
2. A full tuition refund will be made for payments made in advance of a class start if requested before the start date.
3. A full tuition refund will be made for payments made in advance if a class is cancelled by the International Language Institute, MD.
4. There is no discount or refund for days on which ILI is closed because of holidays, bad weather or other emergencies.
5. A tuition refund will be given to students who have already begun classes if a **refund request form** was completed by the student by the last day of attendance and given to an Admissions Representative or the Program Director. The weekly tuition rate is used to calculate the amount of tuition retained for the weeks attended. Any portion of a week in attendance will be considered a full week of attendance for this purpose.

6. Private, semi-private and special group classes cancelled by the student(s), including "no-shows", may be made up only if notice is given by the student to ILI either by phone (301) 527-0600 or by email to ilimd@transemanitics.com at least **24 hours prior** to the scheduled class(es) and by noon Friday for any class(es) held on Saturday, Sunday or Monday. If a student fails to cancel on time, full tuition must be paid for the missed class(es). Semi-private and small group classes have to be cancelled by all students enrolled in class, cancellation of just one student is not accepted and does not release that student from paying for the missed class. Classes should not be cancelled with the instructor.
